RESOLUTION APPROVING ON FIRST, SECOND, THIRD AND FINAL READING AN ORDINANCE REVERTING THE AMOUNT OF EIGHTY-THREE MILLION FOUR HUNDRED FIFTY-ONE THOUSAND THREE HUNDRED PESOS (PHP83,451,300.00) TO BE TAKEN FROM THE VARIOUS SOURCES AND REAPPROPRIATING THE SAME FOR THE VARIOUS NEEDS OF THE CITY, PER LETTER REQUEST OF THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ DATED NOVEMBER 14, 2022 AND CERTIFICATION ISSUED BY THE CITY TREASURER, MS. ARLENE J. MEMORIA DATED NOVEMBER 2, 2022 AND THE CITY BUDGET OFFICER, MS. MARIA IMELDA A. WILLIAMS DATED NOVEMBER 14, 2022, DOCKETED AS SP CORRESPONDENCE NO. 11-22-0705.


