RESOLUTION REQUESTING THE HONORABLE ATTY. BENJAMIN ABALOS, JR., SECRETARY OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), THROUGH THE OFFICE OF THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ, ONE (1) UNIT OF AERIAL LADDER FIRE TRUCK FOR THE USE OF THE BACOLOD CITY GOVERNMENT.

Upon motion of Councilor Psyche Marie E. Sy, seconded by Floor Leader Al Victor A. Espino, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, the delivery of basic services relative to the protection of life and property has always been the major thrust of both the national and local government;

WHEREAS, one of the basic services that should be taken with utmost consideration is fire protection;

WHEREAS, provisions of adequate facilities is vital to the delivery of these services;

WHEREAS, the Bacolod City Government is in need of a unit of aerial ladder fire truck to sufficiently answer the demands for basic services of the growing population;

WHEREAS, the Bacolod City Government firmly believes that the national government is always a partner of local governments specifically in ensuring the provision of adequate basic services;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to request the Honorable Atty. Benjamin Abalos, Jr., Secretary of the Department of the Interior and Local Government (DILG), through the Office of the Honorable City Mayor Alfredo Abelardo B. Benitez, one (1) unit of Aerial Ladder Fire Truck for the use of the Bacolod City Government.


