**RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE BACOLOD CITY MAYOR ALFREDO ABELARDO B. BENITEZ TO IMPLEMENT BACOLOD CITY ORDINANCE NO. 995, SERIES OF 2022 "AN ORDINANCE ESTABLISHING THE ZERO OPEN DEFECATION VERIFICATION AND CERTIFICATION TEAM AS A SUPPLEMENT TO CITY ORDINANCE NO. 881.**

Upon motion of Councilor Claudio Jesus Raymundo A. Puentevella, seconded by Councilor Jason Isidro S. Villarosa, the Sangguniang Panlungsod of Bacolod

**RESOLVED**, to pass the following resolution:

**WHEREAS**, Section 15 of Article II of the 1987 Philippine Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them.

**WHEREAS**, Section 2 of City Ordinance No. 995 states the Creation of ZOD Assessment Team and Section 3 thereof provides for the duties and responsibilities of the team which is composed of the following:

**WHEREAS**, Section 4 of the said ordinance provides for the composition of the ZOD verification Team;

**WHEREAS**, the DOH continues to promote the Zero Open Defecation Program (ZODP) advocacy and health education campaign.

**WHEREAS**, adopting zero open defecation in every barangay aim to encourage every households who practice open defecation to adopt this sanitary practices to avoid sickness, improve their quality of life and well being and improve the sanitation of the community as a whole.

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to respectfully request the Honorable Bacolod City Mayor Alfredo Abelardo B. Benitez to implement Bacolod City Ordinance No. 995, Series of 2022 "An ordinance establishing the Zero Open Defecation Verification and Certification Team as a supplement to City Ordinance No. 881.


