**RESOLUTION SUPPORTING HOUSE BILL NO. 2916 OR OTHERWISE KNOWN AS
A BILL REGULARIZING CONTRACTUAL GOVERNMENT WORKERS THAT HAVE BEEN IN
SERVICE FOR AT LEAST FIVE CONSECUTIVE YEARS.**

Upon motion of Floor Leader Al Victor A. Espino, jointly seconded by Councilors Celia Matea R. Flor, Simplicia Z. Distrito, Renecito S. Novero and Israel P. Salanga, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, the House Committee on Civil Service and Professional approved on 15 November 2022, the consolidation of 10 bills that will enable the regularization and grant of civil service eligibility to casual and contractual government workers that have been in service for at least five years or more;

WHEREAS, the aim of the bill is to reduce labor contractualization in government and to set an example as a good employer by ending labor contractualization;



WHEREAS, it is also the aim of the bill to provide civil service eligibility to non-regular government workers who have served either in national and local government agencies for at least five years or more;

WHEREAS, by granting the said bill, it will serve as an incentive for government workers towards a more productive work and invest more in one's job;

WHEREAS, it is undeniable that long-term contractual workers proved their worthiness of receiving benefits as a regular employee of a government, through their hard work and service for the people;

WHEREAS, the government should provide an opportunity for these dedicated workers a chance to obtain their civil service eligibility considering the services they extend in all government offices as well as their educational and training components;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to support House Bill No. 2916 or otherwise known as a bill regularizing contractual government workers that have been in service for at least five consecutive years.


