**RESOLUTION EXPRESSING SUPPORT TO HOUSE BILLS NOS. 1754, 3256, 4211, 4250, 4548, 5071 AND 5498, AUTHORED BY REPRESENTATIVES, ERIC GO YAP, LEX ANTHONY CRIS COLADA, FRANZ PUMAREN, IVAN HOWARD GUINTU, ERNESTO DIONISIO JR., KRISTINE ALEXIE TUTOR AND BERNADETTE HERRERA, THAT WILL PROVIDE MONTHLY PENSION, FINANCIAL ASSISTANCE AND ALLOWANCE TO OUR INDIGENT PERSONS WITH DISABILITIES (PWDs).**

**WHEREAS**, House Bills Nos. 1754, 3256, 4211, 4250, 4548, 5071 AND 5498, authored by representatives, Eric Go Yap, Lex Anthony Cris Colada, Franz Pumaren, Ivan Howard Guintu, Ernesto Dionisio Jr., Kristine Alexie Tutor and Bernadette Herrera, with the principal objective of providing monthly pension, financial assistance and allowance to our indigent Persons with Disabilities (PWDs);

**WHEREAS**, the Special Committee on PWDs of the House of Representatives recently formed a Technical Working Group to consolidate the House Bills considering that their each and every purpose is similar to one another except as to the process of its implementation which can be unified by the TWG for efficiency and smooth enforcement;

**WHEREAS**, common among these proposed bills is to provide a P2,000 monthly pension to our PWDs for their daily subsistence;
