**RESOLUTION NO. 1110**  
**Series of 2022**

**RESOLUTION DECLARING THE OBSERVANCE OF WORLD AIDS DAY ON  
DECEMBER 1, 2022 AND ENJOINING ALL DEPARTMENTS AND AGENCIES FOR  
SUPPORT AND PARTICIPATION.**

Upon motion of Councilor Claudio Jesus Raymundo A. Puentevella, jointly seconded by Councilors Simplicia Z. Distrito and Em L. Ang, the Sangguniang Panlungsod of Bacolod

**RESOLVED**, to pass the following resolution:

**WHEREAS**, Section 15 of Article II of the 1987 Philippine Constitution provides that the Se State shall protect and promote the right to health of the people and instill health consciousness among them;

**WHEREAS**, according to the World Health Organization, as of 2010 there are already almost Thirty Four Million (34,000,000) people living with aids at all ages with One Million Eight Hundred Thousand (1,800,000) reported deaths around the world;

**WHEREAS**, World AIDS Day brings together people from around the world to raise awareness about HIV/AIDS and demonstrate international solidarity in the face of the pandemic;



**WHEREAS**, each year, on 1 December, the world commemorates World AIDS Day. People around the world unite to show support for people living with HIV and to remember those who have died from AIDS-related illnesses;

**WHEREAS**, every year, World AIDS Day focuses on a specific theme, which this year will be Global solidarity, shared responsibility. This year's theme joins a growing list of challenges that World AIDS Day has alerted people globally;

**WHEREAS**, the day is an opportunity for public and private partners to spread awareness about the status of the pandemic and encourage progress in HIV/AIDS prevention, treatment and care in high prevalence countries and around the world.

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to declare the observance of World Aids Day on December 1, 2022 and enjoining all departments and agencies for support and participation.
