RESOLUTION APPROVING ON FIRST, SECOND, THIRD AND FINAL READING AN APROPRIATION ORDINANCE REVERTING THE AMOUNT OF THIRTY THREE MILLION TWO HUNDRED THOUSAND PESOS (P33,200,000.00) TO BE TAKEN FROM THE VARIOUS SOURCES OF FUNDS AND RE-APPROPRIATING THE SAME TO THE VARIOUS NEEDS OF THE CITY, PER LETTER REQUEST OF THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ AND CERTIFICATIONS OF THE CITY BUDGET OFFICER, MS. MARIA IMELDA A. WILLIAMS, BOTH DATED DECEMBER 7, 2022 AND ACTING-CITY ACCOUNTANT, MS. JEREMAE ANN CERIACO-FLORENTINO DATED DECEMBER 6, 2022, DOCKETED AS SP CORRESPONDENCE NO. 11-22-0793.

Upon motion of Acting Vice Mayor Jude Thaddeus A. Sayson, jointly seconded by Floor Leader Al Victor A. Espino, Councilors Celia Matea R. Flor and Simplicia Z. Distrito, the Sangguniang Panlungsod of Bacolod
