**RESOLUTION NO. 1142**

**RESOLUTION EXPRESSING THE SUPPORT AND COMMITMENT OF THE BACOLOD CITY GOVERNMENT TO THE CITY'S URBAN POOR ON THE OCCASION OF THE ANNUAL URBAN POOR SOLIDARITY WEEK CELEBRATION, AND REQUESTING FOR THE RELEASE OF THE ANNUAL BUDGETARY ALLOCATION FOR THE EVENT.**

**WHEREAS**, Presidential Proclamation No. 367 Series of 1989 was signed by the late President Corazon c. Aquino declaring December 2-8 of every year as Urban Poor Solidarity Week;

**WHEREAS**, this proclamation was aimed at promoting common understanding of the issues and problems on urbanization, urban poverty, the informal settlers and other related concerns, as well as, to foster unity, dialogue and cooperation among government agencies, non-government agencies and the informal settlers on programs and projects aimed at urban poverty alleviation;

**WHEREAS**, the Bacolod City Government is fully committed to these endeavors, programs and projects, and as a concrete support to this annual Urban Poor Solidarity Week Celebration, City Ordinance No. 344 was passed in November 13, 2003 and was later amended by City Ordinance No. 08-16-773, among others, appropriating the amount of FIVE HUNDRED THOUSAND PESOS (P500,000.00) effective Budget Year 2016 and every year thereafter in the Annual Budget, to enhance Bacolod City's budgetary support to this annual event, through the Bacolod Housing Authority;

**WHEREAS**, the present Administration and government of Bacolod City, true to its promise of alleviating the plight of the urban poor and bringing about justice, peace and development to the City, full heartedly expressed its solidarity and support to this Annual Urban Poor Solidarity Week Celebration both in words and in action.
