**RESOLUTION RATIFYING THE BACOLOD TRAFFIC AUTHORITY COUNCIL RESOLUTION NOS. 001, 002 AND 003, ALL SERIES OF 2022, DOCKETED AS SP CORRESPONDENCE NO. 11-22-0786-A, 11-22-0784-A AND 11-22-0785-A, SPECIFICALLY WITH AMENDMENT ON THE 3<sup>RD</sup> WHEREAS OF RESOLUTION NO. 003, WITH COLATILLAS THAT THIS WILL BE SUBJECT TO THE CONTINUING REVIEW OF THE SANGGUNIANG PANLUNGSOD AND SUBJECT FURTHER TO THE REQUIREMENTS OF PUTTING UP THE APPROPRIATE SIGNAGES AND NOTICES BEFORE IMPLEMENTING THE SAME.**

**RESOLVED**, to ratify the Bacolod Traffic Authority Council Resolution Nos. 001, 002 and 003, all Series of 2022, docketed as SP Correspondence No. 11-22-0786-A, 11-22-0784-A and 11-22-0785-A, to wit:





- a) **Resolution No. 001, Series of 2022** - Resolution adopting the Bacolod City Traffic Authority Office (BTAO) proposed one-way scheme (along Lacson Street, Aguinaldo Street and Gatuslao Street) for experimental implementation.
- b) **Resolution No. 002, Series of 2022** - Resolution adopting the Bacolod City Traffic Authority Office (BTAO) proposed total truck ban and re-routing of South Bound Cargo Trucks from Reclamation Area to pass through Araneta Street.
- c) **Resolution No. 003, Series of 2022** - Resolution adopting the Bacolod City Traffic Authority Office (BTAO) proposed amendment of truck ban time. (3<sup>rd</sup> Whereas) WHEREAS, based on the urgent traffic congestion concern, it is important to that the Sec. IV, C, City Ordinance No. 338, Series of 2003 be amended as "Cargo Trucks shall be banned passing the Circumferential Road between **6am to 9pm**".
