

RESOLUTION AUTHORIZING THE CITY MAYOR ALFREDO ABELARDO B. BENITEZ TO SIGN THE PROPOSED MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY OF BACOLOD AND DEPARTMENT OF HEALTH-WESTERN VISAYAS CENTER FOR HEALTH DEVELOPMENT, REPRESENTED BY ADRIANO P. 


