RESOLUTION APPROVING ON FIRST, SECOND, THIRD AND FINAL READING AN APPROPRIATION ORDINANCE REVERTING THE AMOUNT OF FIFTY-NINE MILLION PESOS (P59,000,000.00) TO BE TAKEN FROM THE SAVINGS FROM UNFILLED VACANT POSITIONS AND RE-APPROPRIATING THE SAME TO THE VARIOUS NEEDS OF THE CITY, PER LETTER REQUEST OF THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ AND CERTIFICATION OF THE CITY BUDGET OFFICER, MS. MARIA IMELDA A. WILLIAMS, BOTH DATED DECEMBER 20, 2022, DOCKETED AS SP CORRESPONDENCE NO. 11-22-0853.
