RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ TO SIGN THE PARTIAL COMPROMISE AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY OF BACOLOD, AND DYNASTY AGRICULTURAL CORPORATION IN CIVIL CASE NO. 22-15743, ENTITLED "CITY OF BACOLOD VS. DYNASTY AGRICULTURAL CORPORATION," DOCKETED AS SP CORRESPONDENCE NO. 11-23-0311, WITH A COLATILLA THAT TAXES ON THE PROPERTIES OF DYNASTY AGRICULTURAL CORPORATION SHOULD BE PAID FIRST BEFORE THE RELEASE OF THE AMOUNT IN THE AMICABLE SETTLEMENT.

Upon joint motion of Floor Leader Al Victor A. Espino and Councilor Jude Thaddeus A. Sayson, jointly seconded by Councilors Simplicia Z. Distrito, Celia Matea R. Flor and Jason Isidro S. Villarosa, the Sangguniang Panlungsod of Bacolod

Benitez to sign the Partial Compromise Agreement entered into by and between the City of Bacolod, and Dynasty Agricultural Corporation in Civil Case No. 22-15743, entitled "City of Bacolod vs. Dynasty Agricultural Corporation," docketed as SP Correspondence No. 11-23-0311, with a colatilla that taxes on the properties of Dynasty Agricultural Corporation should be paid first before the release of the amount in the amicable settlement.


