RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ TO SIGN THE PROPOSED CONTRACT OF SERVICES ENTERED INTO BY AND BETWEEN THE CITY OF BACOLOD, AND IPM CONSTRUCTION CORPORATION, REPRESENTED BY ISABELITA P. MERCADO, PRESIDENT, RE: MANAGEMENT AND OPERATION OF SANITARY LANDFILL FACILITY FOR THE PERIOD FROM MAY 1, 2023 TO DECEMBER 31, 2023 IN THE AMOUNT OF SIXTY-THREE MILLION NINE HUNDRED NINETY-NINE THOUSAND PESOS (PHP63,999,000.00), DOCKETED AS SP CORRESPONDENCE NO. 11-23-0397, WITH A CONDITION THAT BEFORE ITS RATIFICATION, A RESOLUTION EVIDENCING THE CORPORATE AUTHORITY OF THE SIGNING OFFICER OF IPM CONSTRUCTION CORPORATION BE ATTACHED AND THAT THE SAME SHALL HAVE BEEN ACKNOWLEDGED OR NOTARIZED ALREADY.

Upon joint motion of Floor Leader Al Victor A. Espino and Councilor Claudio Jesus Raymundo A. Puentevella, jointly seconded by Councilors Em L. Ang, Simplicia Z. Distrito, Jason Isidro S. Villarosa and Celia Matea R. Flor, the Sangguniang Panlungsod of Bacolod

RESOLVED, to authorize the Honorable City Mayor Alfredo Abelardo B. Benitez to sign the proposed Contract of Services entered into by and between the City of Bacolod, and IPM Construction Corporation, represented by Isabelita P. Mercado, President, re: Management and Operation of Sanitary Landfill Facility for the period from May 1, 2023 to December 31, 2023 in the amount of Sixty-Three Million Nine Hundred Ninety-Nine Thousand Pesos (Php63,999,000.00), docketed as SP Correspondence No. 11-23-0397, with a condition that before its ratification, a resolution evidencing the corporate authority of the signing officer of IPM Construction Corporation be attached and that the same shall have been acknowledged or notarized already.
