CITY ORDINANCE NO. 1032 April 12, 2023

AN ORDINANCE AMENDING CERTAIN POSITIONS IN THE PLANTILLA OF PERSONNEL 2023 AS TO ITS POSITION TITLES AND/OR SALARY GRADES.

WHEREAS, on February 28, 2023, the Office of the City Mayor, the Honorable Alfredo Abelardo B. Benitez endorsed the request of the Human Resource Management Services to revise certain positions in the Plantilla of Personnel 2023 as to its Position Title and/or salary grade;

WHEREAS, the request is for the Sangguniang Panlungsod to pass a resolution to correct the same, however, the august body deemed it proper to pass an ordinance instead since the said positions in the Plantilla of Personnel 2023 were all adopted and passed through such legislative measure;

WHEREAS, the errors of the position titles and/or the salary grades were all typographical mistakes and were inadvertently indicated during its preparation;

WHEREAS, the changes to be made in the Plantilla of Personnel will not in any way result to the abolition, diminution, increase or merging of Titles and/or salary grades of any employees, given also that some are still classified as new or vacant.
