CITY ORDINANCE NO. 1039 June 14, 2023

AN ORDINANCE AMENDING SECTION 4 OF CITY ORDINANCE NO. 977 OTHERWISE KNOWN AS 'AN ORDINANCE DECLARING THE MONTH OF OCTOBER AS THE BACOLOD CITY COOPERATIVE MONTH PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES.

WHEREAS, City Ordinance No. 977, Series of 2021 entitled "AN ORDINANCE DECLARING THE MONTH OF OCTOBER AS THE BACOLOD CITY COOPERATIVE MONTH PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES" was passed on 9 December 2021 for the purpose of providing programs and extending recognitions to foster growth of cooperatives;

WHEREAS, the Bacolod City Cooperative Development Council passed Resolution No. 5. Series of 2023 proposing an amendment to Section 4 of City Ordinance No. 977 in order to observe flexibility relative to the Cooperative Month Highlights;

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of Bacolod City in regular session assembled that:

SECTION 1. Section 4 of City Ordinance No. 977 which reads:

"SECTION 4. COOPERATIVE MONTH HIGHLIGHTS. Every last Friday of October of each year will be the day for the highlight of the Bacolod City Cooperative Month. The CCLDO shall conduct activities on the said Day to promote cooperativism."

Shall be amended to read as follows:

"SECTION 4. COOPERATIVE MONTH HIGHLIGHTS. The highlight and culmination date of the City Cooperative Month Celebration for each year shall be determined by the Bacolod City Cooperative Development Council (BCCDC) through its Executive Committee (EXECOM). The CCLDO shall conduct activities on the said Day to culminate all other programmed activities of the year promoting cooperativism."

SECTION 2. Separability Clause. - If the amending provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue to be in full force and effect.

SECTION 3. Repealing Clause. - All other provisions of City Ordinance No. 977 shall remain in force and executory. All ordinances, rules and regulations or part thereof that are inconsistent with the provisions of this ordinance are hereby amended or repealed accordingly.

SECTION 4. Effectivity. - This Ordinance shall take effect immediately upon its approval and proper publication.
