RESOLUTION NO. 451
Series of 2023

RESOLUTION REITERATING THE INDISPENSIBLE COOPERATION OF ALL TELECOMMUNICATIONS NETWORK COMPANIES TO ESTABLISH THEIR RESPECTIVE SIM CARD ASSISTANCE BOOTHS IN THE BACOLOD CITY GOVERNMENT CENTER FOR THE PURPOSE OF SIM CARD REGISTRATION.

Upon motion of Councilor Jason Isidro S. Villarosa, jointly seconded by Floor Leader Al Victor A. Espino and Councilor Claudio Jesus Raymundo A. Puentevella, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, on October 10, 2022, Republic Act No. 11934, or otherwise known as the SIM Card Registration Act was signed by the President and have been passed into law;

WHEREAS, as will be recalled, Resolution No. 127, was passed by this Local Government Unit sincerely requesting all telecommunications to set up assistance booths for the purpose of SIM Card registration;



WHEREAS, it is the intent of this present Resolution to respectfully reiterate the need of assisting the constituents and stakeholders of this City by the telecommunications company operating within the jurisdiction of this City;

WHEREAS, it is still observed that not all members of the society have registered their SIM Cards despite the extension of ninety (90) days promulgated by the National Government;

WHEREAS, the extension has been set to July 25, 2023, as opposed to the original deadline, which was on April 26, 2023;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to reiterate the indispensable cooperation of all telecommunications network companies to establish their respective SIM Card Assistance Booths in the Bacolod City Government Center for the purpose of SIM Card Registration.


