BENITEZ AND RECOMMENDATION OF THE BACOLOD CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL THRU ITS DRRMC RESOLUTION NO. 018, SERIES OF 2023, DOCKETED AS SP CORRESPONDENCE NO. 11-23-0708.**




