
RESOLUTION NO. 814

RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), CITY ENGINEER'S OFFICE AND CITY LEGAL OFFICE TO INVESTIGATE THE ALLEGED ILLEGAL CONSTRUCTION OF CULVERT AT KABIGUAN CREEK, PUROK MABINULIGON II, BARANGAY SUM-AG, WHICH IMPEDES THEIR NATURAL FLOW OF WATER, CAUSING ALLEGED FLOODING TO SEVERAL AREAS IN THE BARANGAY.

Upon motion of Councilor Psyche Marie E. Sy, jointly seconded by Councilors Em L. Ang and Celia Matea R. Flor, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, attached herewith is a letter request of Purok President John Ray Tragico, requesting a copy of the approved subdivision plan for the proposed Jingle Ville Subdivision, Purok Mabinuligon II, Barangay Sum-ag;



WHEREAS, in the said subdivision, there is an alleged illegal construction of culvert at Kabiguan Creek, which impeded the flow of water, causing floodings in the area, affecting several puroks in the Barangay;

WHEREAS, upon checking with the Office of the Bacolod Housing Authority for the approved subdivision plan of the said subdivision, attached herewith is their letter response stating that the "Said subdivision is not even listed in their ledger of the list of subdivisions that were duly issued a Development Permit";

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to request the Department of Public Works and Highways (DPWH), City Engineers Office and City Legal Office to immediately conduct an investigation on the alleged illegal construction of culvert and institute proper measures and solutions to mitigate/eliminate the flooding problem in the area.
