**RESOLUTION APPROVING ON FIRST, SECOND, THIRD AND FINAL READING AN APPROPRIATION ORDINANCE REVERTING THE AMOUNT OF SIXTY-EIGHT MILLION THREE HUNDRED SEVENTY-ONE THOUSAND TWO HUNDRED FIFTY-ONE PESOS AND SEVENTY-FIVE CENTAVOS (PHP68,371,251.75) FROM THE UNOBLIGATED BALANCES OF THE LAND ACCOUNT UNDER THE OFFICE OF THE CITY MAYOR FROM CYs 2017-2022 AND REAPPROPRIATING THE SAME TO THE VARIOUS NEEDS OF THE CITY, PER LETTER-REQUEST OF THE HONORABLE CITY MAYOR ALFREDO ABELARDO B.
