RESOLUTION ADOPTING THE COMMITTEE REPORT SUBMITTED BY COUNCILOR CELIA MATEA R. FLOR, RE: "PROPOSED ORDINANCE AMENDING CITY ORDINANCE 1251 S. 1979 OR AN ACT PROHIBITING THE SALE OF LIQUOR, BEER OR OTHER INTOXICANTS TO PERSON OR PERSONS BELOW 18 YEARS OF AGE AND REQUIRING ALL REFRESHMENT PARLORS, EATING JOINTS, BARS AND OTHER SIMILAR PLACES WHERE LIQUOR, BEER OR OTHER INTOXICANTS ARE BEING SOLD OR DISPENSED, AND REQUIRING THE POSTING OF SIGNS AT LEAST TO THE EFFECT THAT PERSONS BELOW 18 YEARS OF AGE ARE PROHIBITED TO TAKE OR DRINK LIQUOR, BEER OR OTHER INTOXICANTS AND PROVIDING PENALTIES THEREOF", DOCKETED AS SP CORRESPONDENCE NO. 11-23-0673-A.

RESOLVED, to adopt the Committee Report submitted by Councilor Celia Matea R. Flor, re: "Proposed ordinance amending City Ordinance 1251 S. 1979 or an act prohibiting the sale of liquor, beer or other intoxicants to person or persons below 18 years of age and requiring all refreshment parlors, eating joints, bars and other similar places where liquor, beer or other intoxicants are being sold or dispensed, and requiring the posting of signs at least to the effect that persons below 18 years of age are prohibited to take or drink liquor, beer or other intoxicants and providing penalties thereof", docketed as SP Correspondence No. 11-23-0673-A.


