BENITEZ TO SIGN THE PROPOSED MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY OF BACOLOD, AND THE DEPARTMENT OF SCIENCE AND TECHNOLOGY VI, REPRESENTED BY ITS REGIONAL DIRECTOR, ENGR. 
