RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ TO SIGN THE PROPOSED MEMORANDA OF AGREEMENT ENTERED INTO BY AND AMONG THE CITY OF BACOLOD, AND 911 ROVOCA DEVELOPMENT CO., REPRESENTED BY ITS MANAGING PARTNER, MICO JERRICO ACUNA OCTAVIANO AND HOMEWORLD CONSTRUCTION CORPORATION, REPRESENTED BY ITS EXECUTIVE ASSISTANT, ATTY. JOHANNA D. ABANILLA, FOR THE IMPLEMENTATION OF THE PROGRAM: PAMBANSANG PABAHAY PARA SA PILIPINO (4PH) PROGRAM, DOCKETED AS SP CORRESPONDENCE NOS. 11-23-0776 AND 11-23-0777, RESPECTIVELY, WITH A COLATILLA THAT NO RESERVATION OF UNITS AND RESERVATION FEE CAN BE COLLECTED UNTIL SUCH TIME THAT THERE IS A FORMAL TURNOVER OF THE UNITS TO THE CITY GOVERNMENT OF BACOLOD.

Johanna D. Abanilla, for the implementation of the program: Pambansang Pabahay Para sa Pilipino (4Ph) Program, docketed as SP Correspondence Nos. 11-23-0776 and 11-23-0777, respectively, with a colatilla that no reservation of units and reservation fee can be collected until such time that there is a formal turnover of the units to the City Government of Bacolod.


