**RESOLUTION APPROVING ON FIRST, SECOND, THIRD AND FINAL READING AN APPROPRIATION ORDINANCE APPROPRIATING THE AMOUNT OF ONE MILLION FIVE HUNDRED SIXTEEN THOUSAND TWO HUNDRED SEVENTY-SEVEN PESOS AND FORTY-THREE CENTAVOS (P1,516,277.43) TO BE TAKEN FROM THE ACCUMULATED PRIOR YEARS SURPLUS AND REAPPROPRIATING THE SAME TO CITY MAYOR'S OFFICE-OTHER MAINTENANCE AND OPERATING EXPENSES TO BE USED AS PAYMENT FOR THE OUTSTANDING PREMIUMS AND UNPAID DOCUMENTARY STAMPS TAX BILLED BY THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS), PER LETTER-REQUEST OF THE HONORABLE CITY MAYOR ALFREDO ABELARDO B.
