CITY ORDINANCE NO. 1056
December 20, 2023

AN ORDINANCE AMENDING SECTION 1 OF CITY ORDINANCE NO. 956, SERIES OF 2021, ENTITLED: AN ORDINANCE AMENDING SECTION 1 OF CITY ORDINANCE NO. 913, SERIES OF 2019, ENTITLED, "AN ORDINANCE AMENDING SECTION 4 OF CITY ORDINANCE NO. 623, SERIES OF 2012, ENTITLED 'AN ORDINANCE INCREASING THE ALLOWANCE OF THE BARANGAY HEALTH WORKERS (BHW's) IN THE CITY OF BACOLOD'".

WHEREAS, the Department of Health (DOH) recommends a ratio of one (1) Barangay Health Worker per 20 households, however, BHWs in reality typically deal with 200 to 300 households;

WHEREAS, upon review of City Ordinance No. 956, Series of 2021, the current monthly allowance of P 5,500 is not sufficient to meet the current demand of prices of basic commodities.;

WHEREAS, the salary increase is one way of expressing our appreciation to our front-liners who have tirelessly worked to ensure that every Bacolodnon is provided with the proper health care.

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF BACOLOD, in session assembled that:

SECTION 1. Section 1 of City Ordinance No. 956, shall be amended to read as:

The Barangay Health Workers of Bacolod City shall receive a monthly allowance of P7,000.00.

SECTION 2. Effectivity. This Ordinance shall take effect immediately after its due passage and approval.






