**CITY ORDINANCE NO. 1057
December 20, 2023**

AN ORDINANCE AMENDING SECTION 3.1 OF CITY ORDINANCE NO. 342, SERIES OF 2003, ENTITLED: "AN ORDINANCE STRENGTHENING AND INSTITUTIONALIZING THE VARIOUS NUTRITION PROGRAMS AND OTHER RELATED SERVICES OF THE CITY OF BACOLOD, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES".

WHEREAS, the salary increase is one way of expressing our appreciation to our front-liners who have tirelessly worked to ensure that every Bacolodnon is provided with the proper health care.

WHEREAS, Barangay Nutrition Scholar-Workers are considered as modern day heroes because of their unwavering commitment to work with compassion to people they serve as they generously give their time and effort in delivering the public service to their assigned barangay as partners of the government.

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF BACOLOD, in session assembled that:

SECTION 1. Section 3.1 of City Ordinance No. 342, shall be amended to read as:

The Barangay Nutrition Scholars (BNS) of Bacolod City shall receive a monthly allowance of P 7,000.00.

There shall be an automatic review by the City Nutrition Committee after 2 (two) years from the passage of this Ordinance to determine the necessity or propriety of any additional increase to said monthly allowance, taking into consideration the City's personnel ceiling requirements and availability of funds, and to submit its recommendation to the City Mayor and the Sangguniang Panlungsod for consideration and approval.


SECTION 2. Effectivity. This Ordinance shall take effect immediately after its due passage and approval.




