RESOLUTION APPROVING ON FIRST, SECOND, THIRD AND FINAL READING AN APPROPRIATION ORDINANCE REVERTING THE AMOUNT OF FIFTY-FOUR MILLION FIVE HUNDRED THOUSAND PESOS (P54,500,000.00) TO BE TAKEN FROM THE PERSONAL SERVICES SAVINGS FROM UNFILLED VACANT POSITIONS AND VARIOUS MAINTENANCE AND OTHER OPERATING EXPENSES ACCOUNTS AND THE SAME IS REAPPROPRIATED TO SPECIAL PURPOSE APPROPRIATION-OTHER PERSONNEL BENEFITS FUND AND OTHER MAINTENANCE & OPERATING EXPENSES ACCOUNT (UNDER THE CITY MAYOR'S OFFICE & SANGGUNIANG PANLUNGSOD), RESPECTIVELY, PER LETTER-REQUEST OF THE HONORABLE CITY MAYOR ALFREDO ABELARDO B.
