

**RESOLUTION APPROVING ON FIRST, SECOND, THIRD AND FINAL READING AN APPROPRIATION ORDINANCE APPROPRIATING THE AMOUNT OF THIRTY-SIX MILLION FIVE HUNDRED THOUSAND PESOS (P36,500,000.00) TO BE TAKEN FROM THE CY 2022 ACCUMULATED SURPLUS AND UNDERESTIMATED INCOME AND THE SAME IS REAPPROPRIATED TO VARIOUS NEEDS OF THE CITY, PER LETTER-REQUEST OF THE HONORABLE CITY MAYOR ALFREDO ABELARDO B.
