RESOLUTION ALLOWING THE SELLING OF ASSORTED PRODUCTS (FRUITS, NOCHE BUENA ITEMS, AND RTW PRODUCTS) OF THE VARIOUS VENDORS/VENDOR'S ASSOCIATIONS ALONG VARIOUS STREETS/SITES IN BACOLOD CITY, FOR THEIR CHRISTMAS BAZAAR/TRADE FAIR/NEW YEAR'S DAY FAIR, DOCKETED AS SP CORRESPONDENCE NOS. 11-23-0851, 11-23-0875, 11-23-0915, 11-23-0925, 11-23-0926, 11-23-0927, AND 11-23-0928, "WITH A COLATILLA TO REQUEST THE BUSINESS & PERMITS LICENSING OFFICE (BPLO) OR THE CITY ADMINISTRATOR'S OFFICE THAT ONLY REGISTERED BACOLODNON WITH COMELEC ID OR CERTIFICATE WILL BE ALLOWED TO SELL".

Upon motion of Councilor Celia Matea R. Flor, jointly seconded by Councilor Renecito S. Novero, the Sangguniang Panlungsod of Bacolod

RESOLVED, to allow the selling of assorted products (fruits, noche buena items, and RTW products) of the various vendors/vendor's associations along various streets/sites in Bacolod City, for their Christmas Bazaar/Trade Fair/New Year's Day Fair, docketed as SP Correspondence Nos. 11-23-0851, 11-23-0875, 11-23-0915, 11-23-0925, 11-23-0926, 11-23-0927, and 11-23-0928, "with a colatilla to request the Business & Permits Licensing Office (BPLO) or the City Administrator's Office that only registered Bacolodnon with COMELEC ID or certificate will be allowed to sell", to wit:



- 1. Norayda A Senoro, Plaza Fruit Vendors to sell fruits at Bacolod Public Plaza along Gonzaga Street, Bacolod City from December 15, 2023 to January 1, 2023;
- 2. Micro Bacolod Vendors Organization (MBVO) Corporation to set-up a 1-day sale in front of Po's Marketing, Limman's Department Store to BDO Bank, at Araneta Street, Bacolod City on January 1, 2024;
- 3. Micro Bacolod Vendors Organization to occupy the half area of Ballesteros Street for their Christmas Bazaar on December 16, 2023 to January 6, 2024;
- 4. Ma. Sheila Verzosa, President, RTW and Retailers of Metro Bacolod Association, Inc. (RRMBAI) to hold a New Year's Day fair along Araneta, Luzuriaga and Gonzaga Streets on January 1, 2024;
- 5. Burgos Public Market Vendors to sell fruits along the sidewalk of Burgos Public Market on December 26 to 31, 2023;
- 6. Jose Lazaro Aguilar to sell 'ukay-ukay' along Araneta Street in front of Baker's Bake Shop on January 1, 2024;
- 7. Burgos Public Market Vendors to sell fruits along Burgos Street in front of Burgos Public Market on December 15 to 31, 2023; and
- 8. Jeffrey C. Arciaga and Patricia Ann Coulston to sell 'ukay-ukay' along Araneta Street (Limman's) on New Year;
