

**RESOLUTION ALLOWING THE SELLING OF ASSORTED PRODUCTS (FRUITS, NOCHE BUENA ITEMS, AND RTW PRODUCTS) OF THE VARIOUS VENDORS/VENDOR'S ASSOCIATIONS ALONG VARIOUS STREETS/SITES IN BACOLOD CITY, FOR THEIR CHRISTMAS BAZAAR/TRADE FAIR/NEW YEAR'S DAY FAIR, DOCKETED AS SP CORRESPONDENCE NOS. 11-23-0851, 11-23-0875, 11-23-0915, 11-23-0925, 11-23-0926, 11-23-0927, 11-23-0928, 11-23-0961, 11-23-0962, 11-23-0971, 11-23-0972, AND 11-23-0973 "WITH A COLATILLA TO REQUEST THE BUSINESS & PERMITS LICENSING OFFICE (BPLO) OR THE CITY ADMINISTRATOR'S OFFICE THAT ONLY REGISTERED BACOLODNON WITH COMELEC ID OR CERTIFICATE WILL BE ALLOWED TO SELL" AND FURTHER, TO REQUEST OR AUTHORIZE THE CITY ADMINISTRATOR'S OFFICE THROUGH THE CITY MAYOR'S OFFICE, AND THE MARKET SUPERVISORS IN THE RESPECTIVE PUBLIC MARKETS TO IDENTIFY, DESIGNATE AND ASSIGN AREAS FOR SELLING.**

**RESOLVED**, to allow the selling of assorted products (fruits, Noche Buena items, and RTW products) of the various vendors/Vendor's Associations along various streets/sites in Bacolod City, for their Christmas Bazaar/Trade Fair/New Year's Day Fair, docketed as SP Correspondence Nos. 11-23-0851, 11-23-0875, 11-23-0915, 11-23-0925, 11-23-0926, 11-23-0927, 11-23-0928, 11-23-0961, 11-23-0962, 11-23-0971, 11-23-0972, AND 11-23-0973 "with a colatilla to request the Business & Permits Licensing Office (BPLO) or the City Administrator's Office that only registered Bacolodnon with COMELEC ID or certificate will be allowed to sell" and further, to request or authorize the City Administrator's Office through the City Mayor's Office, and the market supervisors in the respective public markets to identify, designate and assign areas for selling.


