

RESOLUTION GRANTING THE REQUEST OF BARANGAY 12, THRU BARANGAY RESOLUTION NO. 144, SERIES OF 2023, ENTITLED: "RESOLUTION RESPECTFULLY REQUESTING SANGGUNIANG PANLUNGSOD TO APPROVE THE REQUEST OF BARANGAY 12, BARANGAY COUNCIL BACOLOD CITY, TO PUT UP A TRADE FAIR FOR THE UPCOMING CHRISTMAS SEASON STARTING FROM NOVEMBER 15, 2023 – JANUARY 02, 2024. ALL EXHIBITORS MUST COORDINATE WITH THE BARANGAY 12 COUNCIL FOR THE POSSIBLE USE AND OCCUPANCY OF THE SIDE WALK ALONG CORNER SAN JUAN AND RIZAL STREETS BESIDES BONGBONG'S AND FR. FERRERO STREET AND LIKewise FOR THE COMPLIANCE OF BUSINESS PERMITS AND OTHER FEES AS BEING PROVIDED FOR BY LAW", DOCKETED AS SP CORRESPONDENCE NO. 11-23-0823.
