**RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ TO STRICTLY IMPLEMENT CITY ORDINANCE NO. 08-14-679 SERIES OF 2014, "AN ORDINANCE AMENDING CITY ORDINANCE NO. 534 DATED APRIL 13, 2011 OTHERWISE KNOWN AS "AN ORDINANCE PROHIBITING THE ACTS OF VANDALISM IMPOSING PENALTIES FOR VIOLATION THEREOF, AND FOR OTHER PURPOSES".**

Upon motion of Councilor Claudio Jesus Raymundo A. Puentevella, jointly seconded by Floor Leader Al Victor A. Espino, Councilors Jason Isidro S. Villarosa, Simplicia Z. Distrito and Celia Matea R. Flor, the Sangguniang Panlungsod of Bacolod

**RESOLVED**, to pass the following resolution:

**WHEREAS**, City Ordinance No. 08-14-679 Series of 2014 "An Ordinance Amending City Ordinance No. 534 dated April 13, 2011 otherwise known as An Ordinance Prohibiting The Acts Of Vandalism Imposing Penalties For Violation Thereof, And For Other Purposes and Section 6 thereof provides that schools are encouraged to include in their values education or edukasyong pagpapahalaga classes, lessons regarding vandalism. All schools shall be enjoined to cooperate with the city government in the conduct of dialogues and values seminars to identify truants and offenders enrolled in their schools and shall undertake measures to discourage or prevent such behavior;

**WHEREAS**, the Bacolod City Police Office shall be requested to conduct regular conference with schools and communities and to create a special team to focus on apprehending violators;

**WHEREAS**, the city shall encourage and support activities of barangays towards the promotion of public, artistic expression of public art and shall allot funds for the activity;

**WHEREAS**, vandalism is a growing problem in the city and it is usually young people who are members of gangs engaged in this illegal activity, and in the last paragraph of Section 5 clearly states that if the violator is a leader of a gang, group or fraternity, he/she will be penalized accordingly, plus restoration of the actual amount of the property damaged and will render school services, if enrolled in a certain school and if not enrolled, shall render community service to the barangay where he/she resides.

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to respectfully request the Honorable City Mayor Alfredo Abelardo B. Benitez to strictly implement City Ordinance No. 08-14-679 Series of 2014, "An ordinance amending City Ordinance No. 534 dated April 13, 2011 otherwise known as "An ordinance prohibiting the acts of vandalism imposing penalties for violation thereof, and for other purposes".
