CEBALLOS, OIC-CITY ENGINEER, OFFICE OF THE CITY ENGINEER, TO THE PROJECT "CONSTRUCTION OF LEGISLATIVE BUILDING", AS REQUIREMENT SET BY THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, DOCKETED AS SP CORRESPONDENCE NO. 11-23-0984.

Upon motion of Floor Leader Al Victor A. Espino, seconded by Councilor Simplicia Z. Distrito, the Sangguniang Panlungsod of Bacolod

Indian Mango Tree – 2 trees (or as determined by the DENR), with a colatilla to strictly adhere to the report of the Department of Environment and Natural Resources (DENR) with regard to the seventeen (17) African Tulip trees, and the two (2) Indian Mango trees.


