**RESOLUTION RESPECTFULLY REQUESTING THE BUREAU OF FIRE PROTECTION OF BACOLOD CITY THROUGH FIRE MARSHAL CHIEF INSPECTOR STEPHEN JARDELEZA TO INTENSIFY THE CAMPAIGN IN THE PREVENTION AND SUPPRESSION OF FIRECRACKER/PYROTECHNICS RELATED FIRE INCIDENTS IN THE CITY OF BACOLOD.**

**RESOLVED**, to pass the following resolution:

**WHEREAS**, Section 5 of Article II of the 1987 Philippine Constitution provides that the maintenance of peace and order, the protection of life, liberty, and property, and the promotion of general welfare are essential for the enjoyment by all the people of the blessings of democracy.

**WHEREAS**, Republic Act No. 7160 or otherwise known as the Local Government Code of 1991 provides that the Local Government Units shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance.



**WHEREAS**, as the citizens and residents of Bacolod City are expected to celebrate the holiday festive of the upcoming new year, firecrackers and pyrotechnics are expected to be used and utilized.

**WHEREAS**, the mishandling or improper use of firecrackers and pyrotechnics can cause destructive fires which is detrimental to the safety and health of the residents and citizens of Bacolod and may be even cause property destruction or even fatalities or injuries.

**WHEREAS**, the City of Bacolod, through the Sangguniang Panlungsod respectfully request the Office of the Bureau of Fire Protection of Bacolod City to intensify its campaign to prevent and suppress destructive fire caused by the firecrackers and pyrotechnics.

**NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, to respectfully request the Bureau of Fire Protection of Bacolod City through Fire Marshal Chief Inspector Stephen Jardeleza to intensify the campaign in the prevention and suppression of firecracker/pyrotechnics related fire incidents in the City of Bacolod.
