WHEREAS, the sale, distribution, and use of prohibited firecrackers poses risk and danger to the safety and health of the general public and can even cause destruction of properties and injuries to the public.

WHEREAS, the City of Government of Bacolod, through the Sangguniang Panlungsod respectfully request the Bacolod City Police Office to intensify the campaign in the prevention and suppression of sale, use or distribution of illegal and prohibited firecrackers in the City of Bacolod.

NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to respectfully request the Bacolod City Police Office through Police Colonel Noel Calderon Aliño to intensify the campaign against the sale and distribution of prohibited firecrackers in the City of Bacolod.
