RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ TO SIGN THE PROPOSED MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY GOVERNMENT OF BACOLOD, AND BACOLOD CITY GOVERNMENT EMPLOYEES MULTI-PURPOSE COOPERATIVE (BACGEM), REPRESENTED BY VICTOR EMMANUEL C. ESPINA, CHAIRPERSON OF THE BOARD OF DIRECTORS, RE: PAYROLL DEDUCTION OF LOAN AMORTIZATION FROM THE SALARY OF COOPERATIVE EMPLOYEE-MEMBER, DOCKETED AS SP CORRESPONDENCE NO. 11-24-0007, PROVIDED THAT THE PROVIDENT FUND ACCOUNT SHOULD COME FIRST AS TO ITS SALARY DEDUCTION.
