RESOLUTION ENDORSING TO THE BACIWA-PRIMEWATER BACOLOD THE LETTER OF PUNONG BARANGAY MA. FEBE F. LEGASPI, BARANGAY HANDUMANAN, REQUESTING ASSISTANCE FROM THE SANGGUNIANG PANLUNGSOD WITH REGARD TO THEIR EXPERIENCE OF SHORTAGE AND SCARCITY OF WATER SUPPLY IN BARANGAY HANDUMANAN AND TO URGE PRIMEWATER TO PROVIDE AND MAINTAIN ADEQUATE WATER SUPPLY TO ITS CONSUMERS IN THE BARANGAY, DOCKETED AS SP CORRESPONDENCE NO. 11-23-0043, FOR ITS APPROPRIATE AND IMMEDIATE ACTION AND TO SUBMIT REPORT TO THE SANGGUNIANG PANLUNGSOD WITHIN 15 DAYS FROM RECEIPT HEREOF.
