RESOLUTION URGING THE CITY ACCOUNTANT, THE CITY BUDGET OFFICER AND THE CITY TREASURER THROUGH THE OFFICE OF MAYOR ALFREDO ABELARDO B. BENITEZ TO IMPLEMENT THE SPORTS TRUST FUND UNDER CITY ORDINANCE NO. 568, DATED DECEMBER 1, 2011.

Upon motion of Acting Floor Leader Em L. Ang, jointly seconded by Councilors Jason Isidro S. Villarosa, Simplicia Z. Distrito and Celia Matea R. Flor, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, City Ordinance No. 568 was duly passed in 2011 to provide a comprehensive sports program in the city and tap the support of the private sector for sports development through sponsorships and donations;

WHEREAS, the aforementioned ordinance, after more than a decade since its passage, has yet to witness the actualization of the Sports Trust Fund, hindering the fulfillment of its intended purpose and the realization of a vibrant sports environment in our city;



WHEREAS, the Sports Trust Fund, as envisioned by City Ordinance No. 568, is crucial for sustaining and enhancing sports programs, facilities, and initiatives within the city, thereby fostering community engagement, promoting physical well-being, and nurturing sporting talent;

WHEREAS, the Sangguniang Panlungsod is vested with the responsibility of ensuring the proper allocation and utilization of funds for the benefit of the community, and we must address any lapse in the implementation of city ordinances that contribute to the welfare and development of our constituents;

WHEREAS, the Sangguniang Panlungsod expresses its strong commitment to the effective implementation of City Ordinance No. 568 and calls upon all relevant city officials and departments to extend their full cooperation and support in realizing the objectives of the said ordinance;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to urge the City Accountant, the City Budget Officer and the City Treasurer through the Office of Mayor Alfredo Abelardo B. Benitez to implement the Sports Trust Fund under City Ordinance No. 568, dated December 1, 2011.
