**RESOLUTION NO. 248
Series of 2024**

RESOLUTION RESPECTFULLY REQUESTING THE BACOLOD CITY HEALTH OFFICE THROUGH THE HONORABLE BACOLOD CITY MAYOR ALFREDO ABELARDO B. BENITEZ TO INTENSIFY THE PREVENTION OF MEASLES IN THE CITY OF BACOLOD.

Upon motion of Councilor Claudio Jesus Raymundo A. Puentevella, jointly seconded by Floor Leader Al Victor A. Espino, Councilors Simplicia Z. Distrito and Cindy T. Rojas, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, Section 15 of Article II of the 1987 Philippine Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Republic Act No. 7160 or otherwise known as the Local Government Code of 1991 provides that the Local Government Units shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, on March 1, 2024, the World Health Organization issued a news release that Western Pacific Countries are at risk of measles outbreaks due to immunization and surveillance gaps;

WHEREAS, further, based on the above-mentioned news release of the WHO, western pacific regions had recorded an increase of 5044 measles cases, and it possess a threat of measles outbreaks in the Philippines, as part of the western pacific region;

WHEREAS, the Bacolod City Health Office is hereby requested to conduct proper monitoring and surveillance of measles cases in the City of Bacolod and to provide adequate measures and programs to prevent or suppress measles cases in the City of Bacolod.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to respectfully request the Bacolod City Health Office through the Honorable Bacolod City Mayor Alfredo Abelardo B. Benitez to intensify the prevention of measles in the City of Bacolod.
