RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE MAYOR ALFREDO ABELARDO B. BENITEZ TO CONVENE THE BACOLOD FILM FESTIVAL COUNCIL UNDER CITY ORDINANCE NO. 1061 OTHERWISE KNOWN AS THE BACOLOD FILM FESTIVAL ORDINANCE.

Upon motion of Councilor Cindy T. Rojas, jointly seconded by Councilors Celia Matea R. Flor and Israel P. Salanga, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, City Ordinance No. 1061 otherwise known as the Bacolod Film Festival Ordinance was passed last February 14, 2024 with the aim to promote the development of the local film industry, provide a venue for showcasing artistic talents and enhance cultural appreciation;

WHEREAS, Section 4 of the aforesaid Ordinance mandates the creation of a council that will organize and oversee the Bacolod Film Festival and ensure the smooth implementation of the Ordinance;



WHEREAS, part of the functions and responsibilities of the council are: 1) to formulate policies and guidelines for the selection and screening of films to be featured in the festival, 2) appoint the festival director who will manage the operations of the festival, 3) set the theme for the film festival for each year, and 4) allocate and manage funds appropriated for the Bacolod Film Festival;

WHEREAS, given the above-mentioned functions and responsibilities of the council, it is essential for the commencement of the operations of the film festival and also in the daily monitoring and supervision of the same;

WHEREAS, the Sangguniang Panlungsod humbly requests the convening of the Bacolod Film Festival Council so that the City will have its first-ever film festival happening this year, not only helping the filmmakers and their crew but also boosting the local economy and local tourism as it will drive residents from nearby towns and cities to come to Bacolod City and watch the selected films of the festival and also to the awards night;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to respectfully request the Honorable Mayor Alfredo Abelardo B. Benitez to convene the Bacolod Film Festival Council under City Ordinance No. 1061 otherwise known as the Bacolod Film Festival Ordinance.


