RESOLUTION ENDORSING TO THE LOCAL ZONING REVIEW COMMITTEE (LZRC), THE LETTER FROM PHILIPPINE SPAN ASIA CARRIER CORPORATION, REQUESTING TO REZONE THEIR PROPERTIES TO ALLOW CONSTRUCTION AND OPERATION OF A COLD STORAGE FACILITY, LOCATED IN GREENPLAINS SUBDIVISION, BARANGAY SINGCANG-AIRPORT, BACOLOD CITY, WITH TOTAL AREA OF APPROXIMATELY 5,017 SQ. M., CURRENTLY UNDER COMMERCIAL 3 ZONE, DOCKETED AS SP CORRESPONDENCE NO. 11-24-0256, FOR CONSIDERATION.
