RESOLUTION RATIFYING THE CONTRACT AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY OF BACOLOD, REPRESENTED BY THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ, AND IPM CONSTRUCTION AND DEVELOPMENT CORPORATION, REPRESENTED BY ITS PRESIDENT, ISABELITA P. MERCADO, RE: MANAGEMENT, OPERATION AND MAINTENANCE OF THE BACOLOD SANITARY LANDFILL FACILITY FOR THE PERIOD FROM MAY 1, 2024 TO DECEMBER 31, 2024, AND CONSTRUCTION OF SANITARY LANDFILL CELL NO. 4 IN BARANGAY FELISA, BACOLOD CITY IN THE TOTAL AMOUNT OF ONE HUNDRED TWENTY-THREE MILLION TWO HUNDRED FIFTY-FIVE THOUSAND SIX HUNDRED THIRTY-SEVEN PESOS AND EIGHTY-ONE CENTAVOS (PHP123,255,637.81), DULY NOTARIZED AND DOCKETED AS SP CORRESPONDENCE NO. 11-24-0257-A.
