**RESOLUTION CREATING AN AD HOC COMMITTEE TO REVIEW AND INVESTIGATE THE ENFORCEMENT, APPLICATION AND EXECUTION OF THE COMPREHENSIVE REVISED RECLAMATION AGREEMENT AND ALL OTHER RELEVANT CONTRACTS AND/OR AGREEMENTS IN RELATION TO THE BREDCO RECLAMATION PROJECT/S ENTERED INTO BY THE CITY OF BACOLOD AND THE BACOLOD REAL ESTATE DEVELOPMENT CORPORATION.**


