RESOLUTION APPROVING ON FIRST, SECOND, THIRD AND FINAL READING "AN APPROPRIATION ORDINANCE REVERTING THE AMOUNT OF FIFTY-SEVEN MILLION TWO HUNDRED THIRTY THOUSAND PESOS (P57,230,000.00) TO BE TAKEN FROM THE PRIOR YEAR'S UNOBLIGATED BALANCES-CAPITAL EXPENDITURES UNDER THE OFFICE OF THE CITY MAYOR FROM CYs 2015-2022, AND RE-APPROPRIATING THE SAME FOR THE VARIOUS NEEDS OF THE CITY, PER LETTER-REQUEST OF THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. 
