RESOLUTION ADOPTING THE COMMITTEE REPORT SUBMITTED BY COUNCILOR VLADIMIR S. GONZALEZ, RE: PROPOSED "RESOLUTION ADOPTING AND APPROVING THE PROPOSED HOMELOT FAIR MARKET VALUES, BASED ON THE BUREAU OF INTERNAL REVENUE (BIR) ZONAL EVALUATION VALUE, PARTICULARLY FOR THE FOLLOWING RELOCATION SITES ONLY: 1)PROGRESO VILLAGE RELOCATION SITE I (ABADA-ESCAJ) – P1,800.00; 2)PROGRESO VILLAGE RELOCATION SITE II (ARAO) – P1,800.00; AND URGING THE CITY MAYOR OF BACOLOD CITY TO IMMEDIATELY START THE SELLING AND DISTRIBUTION OF THE CITY HOMELOTS IN THESE RELOCATION SITES TO QUALIFIED BENEFICIARIES, IN ACCORDANCE WITH CITY ORDINANCE 1040, OTHERWISE KNOWN AS THE HOMELOT ORDINANCE OF BACOLOD CITY", DOCKETED AS SP CORRESPONDENCE NO. 11-23-0634-D.

Gonzalez, re: "Proposed resolution adopting and approving the proposed Homelot Fair Market Values, based on the Bureau of Internal Revenue (BIR) Zonal Evaluation Value, particularly for the following relocation sites only: 1) Progreso Village Relocation Site I (Abada-Escay) – P1,800.00; 2) Progreso Village Relocation Site II (Arao) – P1,800.00; and urging the City Mayor of Bacolod City to immediately start the selling and distribution of the City Homelots in these relocation sites to qualified beneficiaries, in accordance with City Ordinance 1040, otherwise known as the Homelot Ordinance of Bacolod City", docketed as SP Correspondence No. 11-23-0634-D.


