RESOLUTION REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES THROUGH ITS COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICE, BAGO CITY, FOR THE SURVEY AND TITLING OF IDENTIFIED SITES (PUBLIC LAND) BEING UTILIZED FOR BARANGAY SITE AND OTHER RELATED GOVERNMENT FACILITIES AND INSTITUTIONS AND PORTIONS UTILIZED FOR RESIDENTIAL PURPOSES BY THE RESIDENTS OF BARANGAYS BANAGO, 1, SINGCANG-AIRPORT, TANGUB, PAHANOCOY, AND PUNTA TAYTAY, ALL OF BACOLOD CITY, PER LETTER-REQUEST OF THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. 
