MALDE, JR., TO DO THE FOLLOWING IN RELATION TO SPECIAL PROCEEDING CASE NO. 24-03237, ENTITLED: "IN THE MATTER OF THE PETITION FOR ISSUANCE OF A WRIT OF HABEAS CORPUS OVER THE PERSONS OF MADDOX KILLIAN HEGGE, JACK HEGGE AND ROARKE HEGGE, WESTLY T. Malde, Jr., to do the following in relation to Special Proceeding Case No. 24-03237, entitled: "In the matter of the petition for issuance of a Writ of Habeas Corpus over the Persons of Maddox Killian Hegge, Jack Hegge and Roarke Hegge, Westly T. Hegge versus the Department of Social Services and Development Office of Bacolod City, represented by Alma Gustilo and Juan Paulo Sajo, Jenil Doronila, Lyndel Diane Tarog and Shaquil Yasas", to wit:

- a) Represent the DSSD in all stages of the case, including the pre-trial, alternative dispute resolution and judicial dispute resolution;
- b) Enter into an amicable settlement as they may deem necessary and advantageous, or to submit to alternative modes of dispute resolution;
- c) Enter and make stipulations of facts and make admissions of facts and documents; and
- d) Sign and deliver the preliminary conference order of the Honorable Court, to sign, execute and deliver compromise agreements and other pertinent documents that may be issued during the trial;


