## RESOLUTION NO. 475 Series of 2024

RESOLUTION REQUESTING THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) TO SUBMIT AN INSPECTION REPORT TO THE SANGGUNIAN OF THE CONTRACTOR'S COMPLIANCE ON THE OCCUPATIONAL SAFETY AND HEALTH STANDARDS OF BUNKHOUSE CONSTRUCTION IN BARANGAY MANDALAGAN, AS PER RESOLUTION NO. 396, SERIES OF 2024.

Upon motion of Councilor Vladimir S. Gonzalez, jointly seconded by Councilors Em L. Ang, Israel P. Salanga, Simplicia Z. Distrito and Renecito S. Novero, the Sangguniang Panlungsod of Bacolod

**RESOLVED**, to pass the following resolution:

WHEREAS, Sangguniang Panlungsod Resolution No. 396, Series of 2024 adopted the Committee Report submitted by Hon. Vladimir S. Gonzales, and Psyche Marie E. Sy, Re: Letter of Kaakbay Village Homeowners Association, Inc. requesting assistance to resolve and facilitate their concern regarding the construction of a bunkhouse for construction workers on a residential lot in their area by Rockwell Land Development, Inc. in Barangay Mandalagan, Bacolod City, docketed as SP Correspondence No. 11-24-0368-A.



WHEREAS, Department of Labor and Employment (DOLE) representative, Milsan F. De Los Reyes attended the committee hearing dated May 2, 2024, and agreed to conduct the necessary inspection of Rockwell Development Inc.'s contractor or sub-contractor;

WHEREAS, DOLE Order No. 13, S. of 1998 or the Guidelines Governing Occupational Safety and Health in the Construction Industry, states that employers are to provide workers the following to ensure humane working conditions: adequate supply of safe drinking water; adequate sanitary and washing facilities; suitable living accommodation for workers.

WHEREAS, Section 19.1 thereof, states that after due process and referral to the Philippine Contractor Board (PCAB), any act or omission committed by construction contractors in violation of labor standards, safety rules and regulations, and other pertinent policies shall be a prima facie case of construction malperformance under R.A. 4566 (Constructors' Licensing Law), as amended and its Implementing Rules and Regulations.

**WHEREAS**, Section 19.2 thereof provides that in cases of imminent danger, the DOLE Regional Director may issue a stoppage order which shall remain in effect until the danger is removed or corrected.

WHEREAS, this DOLE inspection is necessary and urgent for safety, and welfare of construction workers.

NOW THEREFORE BE IT RESOLVED AS IT IS HEREBY RESOLVED, to request the Department of Labor and Employment (DOLE) to submit an inspection report to the Sanggunian of the Contractor's Compliance on the Occupational Safety and Health Standards of Bunkhouse Construction in Barangay Mandalagan, as per Resolution No. 396, Series of 2024.
