RESOLUTION NO. 504 Series of 2024

RESOLUTION ACKNOWLEDGING SEVERAL LOCAL PUBLICATIONS AS NARRATIVE OF THE HISTORY AND CULTURE OF BACOLOD CITY.

Upon motion of Councilor Israel P. Salanga, seconded by Councilor Em L. Ang, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, Section 15 and 16, Article XIV of the 1987 Constitution states that "The State shall conserve, promote, and popularize the nation's historical and cultural heritage and resources, as well as artistic creations." and "All the country's artistic and historic wealth constitutes the cultural treasure of the nation and shall be under the protection of the State which may regulate its disposition.";



WHEREAS, according to Section 2 of Republic Act (R.A.) No. 10086 also known as the "Strengthening People's Nationalism Through Philippine History Act", the State shall provide the means to strengthen people's nationalism, love of country, respect for its heroes and pride for the people's accomplishments by reinforcing the importance of Philippine national and local history in daily life with the end in view of raising social consciousness; reinvigorating government support for historical research; and sustaining and enhancing programs for the protection, preservation and conservation of historical relics and memorabilia, monuments, sites and other historical resources;

WHEREAS, it is provided for in Republic Act No. 10066 or the "National Cultural Heritage Act of 2009", that in the pursuit of cultural preservation as a strategy for maintaining Filipino identity, the said law shall pursue the following objectives: (a) Protect, preserve, conserve and promote the nation's cultural heritage, is property and histories, and the ethnicity of local communities; (b) Establish and strengthen cultural institutions; and (c) Protect cultural workers and ensure their professional development and well-being;

WHEREAS, considering that it is a declared policy of the state to preserve, promote and conserve local history there is a need for Bacolod to acknowledge publications which narrate and promote the history and culture of Bacolod City in furtherance of raising social consciousness, cultural preservation, and maintaining local identity;

WHEREAS, there are several books and publications authored by writers from Bacolod which accurately narrate the rich history and unique culture of Bacolod City;

WHEREAS, the books and publications which contained a thorough and factual narrative of Bacolod City's history and culture need to be preserved as part of the local literature for the education and reference of its readers which are the public in general.
