RESOLUTION NO. 522

RESOLUTION ENJOINING THE PARTICIPATION OF ALL CITY GOVERNMENT DEPARTMENTS, EDUCATIONAL INSTITUTIONS, THE SIXTY-ONE (61) BARANGAYS AND ALL RESIDENTS OF BACOLOD CITY TO THE CELEBRATION OF THE "NATIONAL DISABILITY RIGHTS WEEK" FROM JULY 17 TO 23, 2024.

Upon motion of Councilor Simplicia Z. Distrito, jointly seconded by Councilors Claudio Jesus Raymundo A. Puentevella and Em L. Ang, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, on June 13, 2024, President Ferdinand R. Marcos, Jr., issued Proclamation No. 597 entitled, "DECLARING THE PERIOD OF 17 TO 23 JULY OF EVERY YEAR AS 'NATIONAL DISABILITY RIGHTS WEEK'";

WHEREAS, the said Proclamation repealed Proclamation No. 1870 (s. 1979) that declared the third week of July of every year as the "National Disability Prevention and Rehabilitation (NDPR) Week" and Proclamation No. 361 (s. 2000) that declared July 23 of every year as the culmination of the NDPR Week, in commemoration of the date of birth of the sublime paralytic, Apolinario Mabini;

WHEREAS, the repeal was done so as to make the celebration consistent with the purpose of the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD) and to promote a rights-based approach on the celebration (Proclamation No. 597);


WHEREAS, despite of the repeal, purpose of the celebration still holds true that this is the time to stimulate public awareness of the problems of disability, encourage every citizen to take active responsibility in the uplifting of the economic and social conditions of the disabled members of our society, and highlight the nation's efforts towards disability prevention and rehabilitation;

WHEREAS, all City Government employees, Department Heads, Barangay Officials, School administrators and personnel, students and residents are being enjoined to take part in this week-long celebration to show our appreciation, gratitude, love, and respect to persons with disability.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to enjoin the participation of all City Government Departments, Educational Institutions, the sixty-one (61) Barangays and all residents of Bacolod City to the celebration of the "National Disability Rights Week" from July 17 to 23, 2024.
