**RESOLUTION APPROVING ON FIRST, SECOND, THIRD AND FINAL READING "AN APPROPRIATION ORDINANCE REVERTING THE AMOUNT OF THIRTY MILLION FIVE HUNDRED TWENTY-NINE THOUSAND THREE HUNDRED EIGHTY-EIGHT PESOS AND FORTY-SEVEN CENTAVOS (PHP30,529,388.47) TO BE TAKEN FROM MATURED SPECIAL TRUST FUND TO DONATIONS ACCOUNT UNDER THE CITY MAYOR'S OFFICE, PER LETTER REQUEST OF THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. 
